Lynn Courson presented a request from Gary Ricketson to allow him to reside in his camper/trailer on the lot at 1309 Camden Avenue while building his house. Ms. Courson advised that current zoning only allows campers and trailers in the C-I Commercial Interchange zoning district. Ms. Courson stated that Mr. Ricketson was not planning to hook the camper up to water and sewer but would do so when the house was completed. He plans to have a portapotty placed on the lot. The Council discussed a time limit on building the home. The Council requested staff to gather more specific information with regards to the type of camper Mr. Ricketson has. They would like to ensure that he taps into the water and sewer with the camper rather than allowing for a port-a-potty. The item was tabled until the next City Council meeting.

Public Comments:

Sheila Sapp thanked the Council for the Old Theater Park. Ms. Sapp requested another street light be placed on the south side of the park. The Council requested that staff check with Georgia Power on the request.

Samantha Young thanked Jimmie Cohen and the Public Works department for the maintenance of the Old Theater Park.
